
The number of vacancies mentioned above may increase or decrease, category-wise due to administrative reason.

The age of the candidate should not be below 18 years and more than 45 years, as on 1<sup>st</sup> day of January, 2020. (Relaxation in upper age limit is admissible as per Rules). The applications complete in all respect, alongwith attested copies of certificate, should reach in this office on or before **10.01.2020**. The incomplete applications or applications received after due date, shall not be entertained and rejected without any intimation to the candidate concerned. After the last date of receipt of application, these shall be scrutinized in the office. The list of eligible candidates will then be put in the District Court Website, with the Roll Numbers.

All the candidates should visit the website of District Court, Dharamshala: <https://districts.ecourts.gov.in/kangra> regularly for information/ date of interview etc. The eligible candidates, whose name shall figure in the list of eligible candidates, shall have to download the Admit Card from the District Court website. The candidate shall be required to affix the same passport size photograph on the Admit Card, which he has affixed in the application form. The Photo on the Admit Card shall be attested by any Gazetted Officer/Pradhan Panchayat/ Municipal Councilor. No candidate shall be allowed to appear in interview, unless he has Admit card, duly attested, as aforesaid, alongwith his Identity Card. It is also informed that no separate call letters shall be issued. The candidates have to appear for interview on the dates specified in the District Court website, as per their Roll numbers.
