**ADVERTISEMENT NOTICE**

The High Court of Himachal Pradesh invites applications either in online or offline mode from the eligible desirous candidates for filling-up 04 (four) vacant posts of **Safai Karamchari** on the establishment of High Court, as per the eligibility criterion etc., prescribed hereunder :

However, the candidates who had already applied for the aforementioned posts in response to the High Court Registry earlier Advertisement Notice No.HHC/Estt.7(1)/92-I-16907-11, dated 19/21.06.2019 (published in the Hindi & English daily News Papers "Amar Ujala" and "The Tribune" on 22.06.2019), **need not to apply again**, provided they were clearly eligible with regard to their requisite qualifications & experience etc.

The applications are acceptable in both online and offline modes. However, those candidates who are desirous to apply through online mode, may use recruitment web portal link at url i.e., <https://hphcrecruitment.in/Public/Index> as well as another link provided on our website i.e. <https://hphighcourt.nic.in/> at the main tab 'Recruitment' or 'Recruitment Portal Login' under "Important Links". The candidates, who are desirous to apply through offline mode are required to fill-up the enclosed prescribed application format in accordance with the instructions issued in this behalf. **The last date for applying for the aforesaid posts is 04.03.2020.** However, the applications submitted in offline mode must reach in this High Court Registry on or before the aforementioned last date, complete in all respect before office hours.

No person shall be eligible for direct recruitment to the service if he is below **18 years** of age and above than **45 years** of age as on the date of issuance of advertisement notice. However, in case, candidate belongs to Scheduled Caste, Scheduled Tribe and Other Backward Classes, the upper age limit shall be the same as may be prescribed by the State Government for entry into service from time to time for such candidates.

The fee structure for the **General (UR) category and other reserved categories shall be as under :-**

**:: The candidates applying in ONLINE MODE ::**

- (i) For General (UR) category : Rs.340/- (plus GST as applicable)
- (ii) For Other reserved categories : Rs.190/- (plus GST as applicable)

**:: The candidates applying in OFFLINE MODE ::  
(Only in the shape of Indian Postal Orders (IPOs))**

- (i) For General (Unreserved) category : Rs.300/-
- (ii) For Other reserved categories : Rs.150/-

The candidates applying through offline mode shall have to pay their fees only in the shape of IPO(s) drawn in favour of 'The Registrar General, H.P. High Court, Shimla.


