## **GENERAL TERMS AND CONDITIONS**

1. सभी पद कमांद स्थित भा. प्रौ. स. मंडी हिमाचल प्रदेश में है।

All posts are tenable in IIT Mandi at Kamand, District Mandi, Himachal Pradesh.

2. आरम्भ में सभी पद पांच वर्ष के अनुबंध पर हैं तथा अनुबन्ध अविध पूर्ण होने पर स्वतः ही समाप्त हो जाएंगे। यद्यपि, नियुक्त कर्मचारी के कार्य प्रदर्शन के आधार पर अनुबंध समाप्ति से पहले सम्भाव्य नियमितीकरण के लिए उसके कार्य का मूल्यांकन किया जा सकता है। उपयुक्त पाये जाने पर उम्मीदवार को परिवीक्षा के आधार पर विधिवत प्रस्तावित पद पर नियुक्ति दी जा सकती है। असाधारण कार्य प्रदर्शन करने पर तथा विधिवत प्रस्तावित पद पर दो वर्ष पर्ण होने पर विधिवत प्रस्तावित पद के लिए समीक्षा की जा सकती है।
